

CLUB J Admission Agreement 2011-2012

Basic Service:

Club J begins when the school day is over. Children are brought to the JCC from various schools to participate in an enrichment base after school program that is designed for families that need the support and convenience of a daily after school schedule for their children in kindergarten through fifth grade. Club J promotes friendships that last a lifetime.

Payment Provisions:

- Enrichment participants will be charged in full upon receipt of the application.
- Rates for Club J program – Please circle the program for which you are enrolling your child.

- Club J fees are charged automatically to a credit card the 1st of each month.
- Fees are set for the entire school year and are only pro-rated for the months listed.

August – TVT pay for two week of Club, September – 25% VV pro-rated, October – 50% VV pro-rated, November – Full, December – 25% pro-rated, January – FULL, February – 25% pro-rated NCE/Andersen, pay 4 days camp, March – 25% VV pro-rated, April – 25% Pro-rated NCE/Andersen, 50% TVT/VV Pro-rated, May – Full, June –50% TVT pro-rated

- If you drop Club J during the school year and start up again you will be

charged a \$75 drop fee/child.

Modification Conditions

If you wish to change a schedule a notification must be in writing by the 15th of the month prior to the new schedule taking effect. No price adjustments can be made in the middle of the month for a schedule change.

Refund Policy

There are **NO** refunds on Club J after school program fees or enrichment classes once the registration period has ended.

Termination Conditions

If you wish to withdraw from the program, you must inform the JCC in writing by the 15th of the month for withdrawal for the following month and a \$75 drop-fee will be charged on your last months statement.

Rights of the Licensing Agency

Full payment must accompany all registration for classes and programs. Only members in good standing (current payments for the duration of the program) can register or receive members-only discounts. Fees may be paid in person or by mail. You may pay by VISA, American Express or Master Card.

The JCC reserves the right to cancel any class for insufficient registration. Participants will be notified as soon as possible and their fees refunded. Some classes maybe open only to members. If you are not a member you may register for classes were specified at the public rate.
